AN ORDINANCE OF THE COUNTY OF CLEARWATER, A POLITICAL SUBDIVISION OF THE STATE OF IDAHO, AMENDING CLEARWATER COUNTY BUILDING CODE ORDINANCE 43 WITH THE CODES ADOPTED AND INCORPORATED BY REFERENCE INTO IDAPA 07.03.01 BY THE IDAHO BUILDING CODE BOARD OF THE DIVISION OF BUILDING SAFETY; THE 2012 VERSIONS OF THE INTERNATIONAL BUILDING CODE AND INTERNATIONAL EXISTING BUILDING CODE, AND THE 2009 VERSIONS OF THE INTERNATIONAL RESIDENTIAL CODE PARTS I-IV AND IX AND THE INTERNATIONAL ENERGY CONSERVATION CODE; PROVIDING EXCEPTIONS, INSERTIONS, AND AMENDMENTS THERETO; PROVIDING FOR FEES, PROVIDING THAT A PERMIT IS REQUIRED FOR INSTALLATION OF A MOBILE/MANUFACTURED HOME, PROVIDING FOR EXEMPTIONS; PROVIDING FOR SEVERABILITY; REPEALING CONFLICTING ORDINANCES AND PROVIDING AN EFFECTIVE DATE.
